# Judge Schechter to speak at MCBA luncheon April 5, 2018

Merced County Superior Court Judge Jeanne E. Schechter will be the speaker on the required topic of **Legal Ethics** for the next MCBA luncheon, scheduled for noon, April 5, 2018 at the Elks Lodge, at 1910 M Street, Merced.



Judge Schechter was appointed as a Merced County Superior Court Judge in 2017 following her distinguished service as a Merced County Court Commissioner from 2012 through 2017. Prior to her appointment as Commissioner, Judge Schechter served as a Chief Deputy City Attorney at the Merced City Attorney's Office from 2004 through 2012, and as a Senior Deputy District Attorney at the Stanislaus County District Attorney's Office from 1991 to 2004. Judge Schechter was a sole practitioner from 1990 to 1991. She earned a Juris Doctor degree from Loyola Law School, Los Angeles and a Bachelor of Science degree from Ohio State University.

Judge Schechter often attends the MCBA luncheon meetings, and we are very grateful for her support.

The California State Bar requires attorneys to have 25 Minimum Continuing Legal Education (MCLE) credits every three years, including four hours of Legal Ethics. Judge Schechter's presentation on Thursday, April 5, 2018, will provide attending attorneys with one hour of MCLE credit on Legal Ethics.

## Mark Your Calendars for Law Day, May 3, 2018!

Our nation's first Law Day was established in 1958 by President Dwight Eisenhower to mark the nation's commitment to the rule of law and the importance of the role of law in our society. In 1961, Congress issued a joint resolution designating May 1st as the official date for celebrating Law Day. For the past few decades, the Merced County Bar Association has celebrated Law Day each year on the first Thursday in May.

This year, the MCBA annual Law Day Celebration will be held May 3, 2018 at the Italo-American Lodge. Our Keynote Speaker is Justice Charles Poochigian of the 5th District Court of Appeal.

With two speakers preceding our Keynote Speaker, Law Day this year promises to be a great day of learning and networking. Our day will begin at the Italo-American Lodge with coffee, donuts, and a one hour MCLE session at 10:00 a.m. followed by an 11:00 a.m. presentation. #### FEE ARBITRATION PANEL

The Merced County Bar Association has been working to establish a Fee Arbitration Panel. The California State Bar will come to Merced to provide the required training, once we have enough volunteers for the Panel.

An attorney volunteer must be an attorney whose area of practice is either civil or criminal law. If the amount in dispute is over \$15,000.00, three arbitrators decide the matter, and one of the three must be a non-attorney lay person arbitrator.

Our primary hold-up in establishing the Panel, is that we need more lay person volunteers. Per the California State Bar guidelines, a lay arbitrator is defined as "a person who has not been admitted to practice law in any jurisdiction and has not worked regularly for a public or private law office or practice, court of law or attended law school for any period of time. Paralegal assistants, law firm staff and law clerks shall not serve as lay arbitrators."
